## INTRODUCTION

NAFTA Production s.r.o. a company authorized to operate in the energy sector in gas production, produces natural gas within the Slovak Republic in accordance with Act 251/2012 Coll. on energy, amending certain laws (Energy Act). This document announces conditions and specifications for the supply of natural gas for period 1 July 2025 – 31 December 2025. The supplied natural gas is eligible for SOS purposes, and it is not intended for the final consumption of the customer.

## 2. BASELINE NATURAL GAS SUPPLY SPECIFICATIONS

**Delivery Period:** from Gas Day 1 July 2025 to Gas Day 31 December 2025

**Contractual Quantity:** 73,912 MWh

**Daily Contractual Quantity:** Monthly Contractual Quantity divided by number of days in respective month

**Daily flexibility (max – min):** max. +25% / –25% of the Daily Contractual Quantity, while respecting the Monthly Contractual Quantity

**Delivery Point:** exit point from the facilities operated by NAFTA Production to the distribution system operated by SPP–distribúcia, a.s.

**Nominations:** D–1 before 3:00 PM CE(S)T

**Re–nominations:** D before 3:00 PM CE(S)T for supply of natural gas after 6:00 PM

The nomination process and follow–up requirements are further defined in Article III of the Gas Supply Agreement, which is a part of this Tender Conditions.

**Payment Terms:** general payment terms are defined in Article IV of the Gas Supply Agreement

**Financial Security:** NAFTA Production may require security instruments (e.g., a bank guarantee or a parent company guarantee) to be submitted following the assessment of the potential customer. More information will be provided to applicants after they complete the registration process.

## 3. PRICING

Fixed unit purchase price in EUR/MWh will be offered by the applicant in the Application. The total purchase price will be calculated by multiplying the unit purchase price and the quantity of natural gas to be supplied during the Delivery Period.

## II. CONDITIONS FOR PARTICIPATION

### 1. REGISTRATION

Any applicant wishing to participate in the tender must register by sending an email to **[gassale@nafta-production.sk](mailto:gassale@nafta-production.sk)**. NAFTA Production will subsequently provide the applicant with a list of documents required for the KYC (Know Your Customer) process, unless this process has already been completed. Additionally, NAFTA Production will inform the applicant of any security instruments that may be required.

### 2. APPLICATION

Registration and application deadlines will be published on NAFTA Production's website. The applicants can submit their application to **[gassale@nafta-production.sk](mailto:gassale@nafta-production.sk)**. The applicant must mention the requested gas quantity (number of lots) and bid the price. The applicant may submit maximum two binding, irrevocable applications by email.

### 3. EVALUATION OF APPLICATIONS

NAFTA Production will evaluate the applications within 30 minutes after the deadline for their submission and announce the results to the **individual applicants**.
