

# CONDITIONS OF TENDER – No. 1 (Gas supply – April 2026)



## INTRODUCTION

NAFTA Production s.r.o. a company authorized to operate in the energy sector in gas production, produces natural gas within the Slovak Republic in accordance with Act 251/2012 Coll. on energy, amending certain laws (Energy Act). This document announces conditions of the tender for the supply of natural gas.

## II. TENDER CONDITIONS

**Contractual Quantity:** 30 000 MWh

**Delivery Point:**

- A) Storage facility NAFTA
- or
- B) Connected storage facility POZAGAS
- or
- C) Exit Point to the distribution system operated by SPP–Distribúcia, a.s. (i.e. 1 000 MWh daily)

**Delivery Period:**

**April 2026**  
In case of Delivery Point A or B – depends on date of agreement’s signature (transfer in gas storage lasts one day).  
In case of Delivery Point C (deliveries to distribution network) – delivery period is:  
1/4/26 – 30/4/26

<b>Period for submission of binding price quotations:</b>	9 <sup>th</sup> March 2026 – 13:00 (CET)
<b>Payment Terms:</b>	general payment terms are defined in Article IV of the Gas Supply Agreement
<b>Financial Security:</b>	NAFTA Production may require security instruments (e.g., a bank guarantee or a parent company guarantee) to be submitted following the assessment of the potential customer. More information will be provided to applicants after they complete the registration process.
<b>Pricing:</b>	Fixed unit purchase price in EUR/MWh will be offered by the applicant in the Application. The total purchase price will be calculated by multiplying the unit purchase price and the quantity of natural gas to be supplied during the Delivery Period.

## III. CONDITIONS FOR PARTICIPATION

### 1. REGISTRATION

Any applicant wishing to participate in the tender must register by sending an email to [gassale@naftaproduction.sk](mailto:gassale@naftaproduction.sk). NAFTA Production will subsequently provide the applicant with a list of documents required for the KYC (Know Your Customer) process, unless this process has already been completed. Additionally, NAFTA Production will inform the applicant of any security instruments that may be required.

### 2. APPLICATION

Conditions of tender will be published on NAFTA Production's website. The applicants can submit their application to [gassale@nafta-production.sk](mailto:gassale@nafta-production.sk). The applicant must mention the requested gas quantity and bid the price. The applicant may submit maximum one binding, irrevocable application by email.

### 3. EVALUATION OF APPLICATIONS

NAFTA Production will evaluate the applications within 30 minutes after the deadline for their submission and announce the results to the individual applicants.
