3.1	Location	 Services provided by the service facility are carried out on the NAFTA Production s.r.o. corporate railway siding located at the perimeter of the Veľké Leváre railway station GPS coordinates: 48.511147°N 17.018495°E Traveling along Route 1100 from Veľké Leváre to Závod, turn right onto the access road just behind the railroad crossing Access to the NAFTA Production s.r.o. siding and the SF is from the ŽSR track that runs from Malacky, at the Veľké Leváre station through the siding operated by SURPACK-VL, a.s., currently in bankruptcy, and the SMARTPOINT s.r.o. railway siding

3.3	Technical Description/Charac teristics	 Rail tankers are only able to be filled at the SF siding with liquid hydrocarbons (crude oil and gas condensate) through two filling racks, either from the hydrocarbon storage area or an ADR truck. It is neither adapted for emptying rail tankers nor electrified. The siding has no constructed loading ramps. Transport in the siding is provided by external means. The non-automatic TOLEDO 8530 type TENZONA single-bridge rail scale is accuracy class III and has a weighing capacity up to 100 tonnes.
